**NOTICE IS HEREBY GIVEN THAT THE ROCHESTER PLANNING COMMISSION** will hold a Public Hearing for the consideration of a site plan request which would include a 25,000 square foot renovation of a portion of Building 100 (advanced aseptic manufacturing suite). The application also includes a second story over the suite to house mechanical systems over the suite renovation area.
