**TO THE QUALIFIED ELECTORS OF THE CITY OF ROCHESTER:**

**PLEASE TAKE NOTICE** that any qualified elector of the City of Rochester who is not already registered, may register to vote at the office of the City Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at [mi.gov/vote](http://mi.gov/vote) and mailed to the City Clerk. Voters who are already registered may update their registration at [www.expressSOS.com](http://www.expressSOS.com).

The last day to register in any manner other than in-person with the local clerk is **Monday, October 24, 2022**.

After this date, anyone who qualifies as an elector may register to vote in person **with proof of residency** (MCL 168.497) at the City of Rochester Clerk's Office, located at 400 Sixth Street, Rochester, MI 48307 at the following times.

- Regular business hours: Monday through Friday, from 8:00 a.m. to 5:00 p.m.
- Saturday, November 5, 2022, from 9:00 a.m. to 5:00 p.m.
- Election Day, Tuesday, November 8, 2022 from 7:00 a.m. to 8:00 p.m.
